1. SITING RELAXATION APPLICATION – 12 CHESTNUT STREET, ALLINGHAM.

Consideration of Report to Council from Infrastructure Engineer dated 14th October, 2011 in relation to a Siting Relaxation Application lodged by Mr. Stanley Braes for a proposed shed and awning to be constructed on vacant land at 12 Chestnut Street, Allingham (Lot 15 on SP179180) 0.5m from the rear boundary and 0.5m from the side boundary adjacent to 14 Chestnut Street, Allingham.

1. <u>SITING RELAXATION APPLICATION – 10 MELALEUCA CLOSE, ALLINGHAM.</u>

Consideration of Report to Council from Infrastructure Engineer dated 14th October, 2011 in relation to a Siting Relaxation Application lodged by Mr. Larry Barnes for a proposed open carport at 10 Melaleuca Close, Allingham (Lot 33 on SP219071) 0.2m from the side boundary setback adjacent to 8 Malaleuca Close, Allingham.

1. PEST SURVEY PLAN.

Consideration of a Pest Survey Plan Program to be conducted for the whole of the Hinchinbrook Local Government area to survey and map areas for the control of Pond Apple, Hymenachne, Giant Sensitive Plant, Mikania Vine, Siam Weed and Acacia curassavica to comply with the Land Protection (Pest and Stock Route Management) Act 2002.

Resolved – In accordance with the Land Protection (Pest and Stock Route Management) Act 2002, Council authorises a Pest Survey Program to be conducted for the whole of the Hinchinbrook Local Government area, valid for a period of three months starting on the 30th September 2011. The purpose of the program is to survey and map areas for the control of Pond Apple, Hymenachne, Giant Sensitive Plant, Mikania Vine, Siam Weed and Acacia curassavica.

2. CYCLONE YASI NDRRA RECOVERY PHASE.

Consideration of Council's NDRRA Restoration Program Summary Report in conjunction with AECOM.

During the wet season they are unable to access their land as at times the water is 3 foot deep in places and they have purchased a canoe to get access to their land, and have to leave their vehicle in Wombat Street. Consideration of advice from Department of Environment and Resource Management (DERM) that the Orpheus Island National Park Management Plan (August 2000) is currently being reviewed and will be replaced with a new plan. Inviting submissions on the draft management plan by Monday 7th November, 2011. (039/0007)

Consideration of Report to Council from Chief Executive Officer dated 20th October, 2011 regarding the Australian Government's establishment of an independent Expert Panel on Constitutional Recognition of Local Government and inviting public submissions which close on the 4th November, 2011.

Resolved – That Council advise that they choose the following options:-

Option 2 for financial recognition is considered very important because the High Court has questioned the constitutional validity of the Federal Government providing funding direct to Councils e.g. Roads to Recovery.

Option 3 for democratic recognition is about ensuring that at a national level there is a guarantee that local Councils must be elected. Currently that is determined by each State via a normal act of Parliament.

With Option 2 as a priority. (Crs. Molachino and Lynch – Carried)
