Sun Smart

Purpose

This policy aims to provide/create:

- Ongoing education that promotes personal responsibility for skin cancer prevention and early detection
- Environments that support SunSmart practices
- An awareness of the need to reschedule outdoor activities to support SunSmart practices.

Background

Queensland has the highest rate of skin cancer in the world. Of all new cancers diagnosed in Australia each year, 80% are skin cancers. Research indicates childhood sun exposure is an important contributing factor to the development of skin cancer in later life. Given students are at school during peak ultraviolet radiation (UVR) times throughout the day, between 10am and 3pm, schools play a major role in both minimising a student's UVR exposure and providing an environment where policies and procedures can positively influence student behaviour.

Skin damage, including skin cancer, is the result of cumulative exposure to the sun. Research shows severe sunburn contributes to skin cancer and other forms of skin damage such as sunspots, blemishes and premature ageing. Most skin damage and skin cancer is therefore preventable.

Ultraviolet radiation (UVR) levels are highest during the hours children are at school. As children will spend a portion of their day outdoors, we are committed to protecting them from the harmful effects of the sun. With this in mind Good Counsel College realises the need to protect children's skin and educate them about SunSmart behaviour, thus reducing the risk of skin damage from exposure to the sun.

Our Commitment

Good Counsel College will:

- Inform parents/carers of the SunSmart policy when they enrol their child
- Increase the amount of shade in the school grounds, where possible, by building shelters and planting trees
- Incorporate education programs that focus on skin cancer prevention into the school curriculum
- Encourage all teachers and staff to act as positive role models for children in all aspects of SunSmart behaviour
- Seek ongoing support from parents/carers and the school community for the SunSmart policy and its implementation, through newsletters and parent/carer meetings
- Ensure all students and staff wear hats that protect the face, neck and ears and SPF 30+ broad-spectrum,
 water-resistant sunscreen when involved in outdoor activities
- Ensure students without adequate sun protection use shaded or covered areas at break times

- Ensure the school dress code conforms with Cancer Council Queensland SunSmart clothing guidelines
- Ensure wherever practicable that outdoor activities take place before 10am and after 3pm
- Ensure adequate shade is provided at sporting carnivals and other outdoor events
- Ensure SPF 30+ broad-spectrum, water-resistant sunscreen is included in the school sports kit
- Ensure parents/carers are notified of details of any school provided sunscreen, in the event that the student may be allergic to the sunscreen being used
- Review the SunSmart policy annually.

Parent / Carer Commitment

Parents/carers will:

- Provide a SunSmart hat (the college hat available from the uniform shop) for their child and ensure they wear it to and from school.
- Ensure their child applies SPF 30+ broad-spectrum, water-resistant sunscreen 20 minutes before leaving for school
- Ensure their child's clothing provides adequate protection from UVR, in line with Cancer Council
 guidelines here. This includes off-campus activities, free dress days and sporting carnivals.

Student Commitment

Students will:

- Be aware of the school's SunSmart policy
- Take responsibility for their own health and safety by being SunSmart
- Comply with SunSmart rules and guidelines by wearing suitable hats, clothing, sunscreen and sunglasses
- Use shaded or covered areas when outdoors
- Act as positive role models for other students in all aspects of SunSmart behaviour
- Help to design and regularly update the SunSmart policy
- Participate in SunSmart education programs.
