## MINUTES OF HINCHINBROOK ROAD SAFETY ADVISORY COMMITTEE HELD ON 2 OCTOBER 2013

Meeting Opened: 10:33am on Wednesday, 2 October 2013.

### 1. **ATTENDANCE**

#### 2. **CONFIRM MINUTES FROM PREVIOUS MEETING OF 7 AUGUST 2013.**

### 3. **BUSINESS ARISING FROM MINUTES - 7 AUGUST 2013.**

Mr Rick Quabba (QMCHA) expressed concerns with people walking in the dark without high visibility clothing or 3.1 embellishments. Mr Quabba suggested buying high visibility ribbon or sashes and donating them to various community groups so the public could obtain one for free.

Dr Jenna Devietti (WE) to look into the possibility of applying for the Department of Transport and Main Roads [DTMR] Road Safety Grants by 30 August 2013.

Ms Kirrily Low (HRSAC Secretary) to send correspondence to various service clubs within the Hinchinbrook Shire.

**ACTION:** 

Dr Jenna Devietti (WE) advised that the HRSAC missed out on the first round of the Road Safety Grants due to a lack of interest from the Ingham's Lions Club and therefore will aim to apply for the next round of funding in February 2014.

Ms Kirrily Low (HRSAC Secretary) to send correspondence to various service clubs within the Hinchinbrook Shire prior to February 2014.

3.2 Mayor Rodger Bow (HRSAC Chairperson) asked DTMR the reasoning behind the two dotted centre lines located in parts on Townsville Road. Mr Jason Macpherson (DTMR) confirmed that the two dotted lines are to separate the traffic from the centre. [Item 3.7]

Mr Jason Macpherson (DTMR) to locate information pamphlets to distribute.

Mr Gerry Southward (DTMR) advised that signs advertising the new lines are to be erected and information will be distributed via email.

Mr Gerry Southward (DTMR) advised that the public can access the guideline on the website regarding the two centre lines and DTMR are looking into advertising information on the new lines in the paper. Mayor Rodger Bow (HSC - HRSAC Chairperson) to advertise information on the Mayors Facebook page.

RESPONSE:

Mr Jason Macpherson (DTMR) advised that signs have gone up in some parts but more signs are yet to go up in other areas.

**3.3** Mr Ricky Quabba (QMCHA) raised concerns regarding tracked cane harvesters driving long distances along public roads. [Item 5.1]

Mayor Rodger Bow (HRSAC Chairperson) advised that he had photos of a tracked cane harvester driving along a public road.

Mayor Rodger Bow (HRSAC Chairperson) to send the photos to Mr Steven Marbelli (Canegrowers). Mr Steven Marbelli (Canegrowers) to place photos in the next canegrowers newsletter to advise the safety concerns.

RESPONSE:

Mr Steven Marbelli (Canegrowers) advised that an email has gone out to the cane harvester operators and the contractor at fault in this particular incident had been advised.

3.4 Mr Steven Marbelli (QMCHA) advising that the shoulders on newly sealed roads are too steep. For example, Cragg Road, Toobanna. [Item 5.3]

3.5 Mr Jason Macpherson (DTMR) advising that the Blackspot submission applications will be sent sometime this week and application will need to be in by 13 September 2013. [Item 5.5]

5.1 Adoption of HRSAC Meeting Dates for 2014

5.3 Mr Robert Giuliano (ECTO) advised that the low dip located on a sweeping corner along Abergowrie Road between rural road number 2815 and 3026 on the inside lane travelling towards Abergowrie is getting worse.

RESPONSE:

Dr Jenna Devietti (WE) to advise Maintenance Supervisor however as investigated once before, repair will depend on funding from DTMR as part of RMPC.

5.4 Ms Alison Barlow (DTMR) advised that there will no longer be registration stickers issued commencing 2014.

**5.5** Ms Alison Barlow (DTMR) advised that licensed members of the public who are 75 years and over will now need to undertake a medical exam each year.

ACTION:

**5.6** Mr Robert Lyon (NQBE) advising that there are deep pot holes located just past Gowrie Creek bridge, Abergowrie, heading towards Ingham.

ACTION: Ms Kirrily Low (HRSAC Secretary) to log a Works Request.

5.7 Luigi Cantoni (APSLINC) advising that a group of youths are standing in car parks shining laser pointers at passing traffic.

ACTION: Mr Geoff Boremann (QPS) advised that these incidents need to be reported to QPS

5.8 Mr Luigi Cantoni advised that the trees located on the corner of Perkins and Abergowrie Road is blocking visibility of traffic coming along Abergowrie Road. Traffic turning onto Abergowrie Road has to pull right out to be able to see if there is any on coming traffic.

**ACTION:** 

Dr Jenna Devietti (WE) advised that as the trees are on private property, Council can't force the land owner to remove them howev1592

er can encourage them to remove them or trim them back.

Dr Jenna Devietti (WE) to undertake inspection of the intersection.

**5.9** Mr Steven Marbelli (Canegrowers) advised that the quality of the new bitumen seal being used for the Natural Disaster Relief and Recovery Arrangements [NDRRA] Infrastructure Restoration Program works is poor and not lasting.

RESPONSE:

Dr Jenna Devietti (WE) advised that Council is aware of this and is being looked into by NDRRA.

**5.10** Mr Don Oswin (Wilmar) requesting status of the proposed removal of the two big trees located on Victoria Mill Road which are currently blocking visibility to traffic.

ACTION: Mr Jason Macpherson (DTMR) to investigate.

**5.11** Mr Don Oswin (Wilmar) advising that traffic turning at the traffic lights from Herbert Street onto Cartwright Street, Ingham, are backing up and stoping on top of the cane train line. Requested thoughts and ideas as to how this can be prevented.

RESPONSE:

It was noted that there is no feasible solution and that it is up to the public to take more notice of where they are stopping.

5.12 Mr Lenny Toscano (Australia Post) advising the current situation with the houses located in the Abergowrie Township along Abergowrie Road having Street numbers rather then Rural numbers. If a resident were to phone emergency services and advise their address, it is unclear to the emergency services of where their residence is situated for e.g. 21 Abergowrie Road, Abergowrie, is a street number but emergency services may think this is a rural number and be looking just outside Trebonne where Abergowrie Road rural numbering starts.

ACTION:

Dr Jenna Devietti (WE) to take comments to Technical Support for consideration in changing the numbers to rural numbers.
