

## NON-SEWERED AREAS – DOCUMENTATION CHECKLIST Hinchinbrook Shire Council Plumbing & Drainage Certification

## Overview

This fact sheet/checklist is intended to assist Hinchinbrook residents in relation to the process for a plumbing/drainage application and includes information on how to complete an application for assessment by Hinchinbrook Shire Council and against the Queensland *Plumbing and Drainage Act 2002*.

## **Plumbing and Drainage Applications for Non-sewered Areas**

The Plumbing & Drainage Act 2002 divides plumbing and drainage work into the following categories:

- Notifiable Work;
- Compliance Assessable Work;
- Minor Work; and
- Unregulated Work

Compliance assessable work is more complex in nature than other types of plumbing and drainage work and has a higher risk of failure. Therefore applications for compliance assessable plumbing and drainage work within non-sewered areas in Hinchinbrook Shire are assessed and approved by Hinchinbrook Shire Council before work begins on-site.

This documentation checklist provides a list of the applicable forms and drawings which need to be provided to Hinchinbrook Shire Council when submitting a plumbing/drainage application.

<u>Please Note:</u> The below list should not be read as a definitive list but used as a guide to assist with preparing an application and if further information is required, you will be notified in due course by Hinchinbrook Shire Council.

Council Plumbing Inspectors are unable to inspect plumbing and drainage works unless a permit for both the plumbing and building (if required) works has been issued.  To arrange a plumbing inspection, contact Council's Building Services on telephone (07) 4776 4637 to speak with a Plumbing Inspector.  Council will endeavour to facilitate inspections to meet the needs of the builder/plumber as much as possible,
however it is preferred that 24 hours' notice is given prior to the scheduled inspection time.
