1.1.1 KELLY THEATRE LEASE

- From 01/07/2014 to 30/06/2015: \$1,000pa (inclusive of GST).
- From 01/07/2015 to end of lease period: \$1,000pa plus CPI increase per year plus 10% of net profits limited to a fixed sum of \$5,000pa (inclusive of GST).
