- 1. OPERATIONAL ACTION 1.0 COMMUNITY
 - 1. <u>INGHAM FOOTBALL CLUB INC.</u>, Ingham, 7th December, 2011, requesting Council to consider waiving the second set of building certification fees applicable for two separate shade structures to be placed side by side between two football fields at the Fairford Road grounds as the Club was originally advised that when applying for grant funding and again when lodging the building application that only one fee would be applicable. Consideration of Report to Council from Manager Engineering Services dated 7th December, 2011 seeking Council's further consideration and direction in relation to the proposed acquisitions for the extension of Johnstone Street behind Casra's Tavern Bar & Grill.

- Musgrave Street, Halifax, from the first house near the wash-away to Macrossan Street 1,313m Total Estimate \$397,183 (Council's contribution \$198,591).
- Leichhardt Street, Allingham, from the first house up to Fern Street 1,037m Total Estimate \$313,693 (Council contribution \$156,846).
- McIlwraith Street from Tully Street to Cartwright Street, Ingham, 1,895m Total Estimate - \$573,238 (Council contribution \$286,619)

5. <u>OPERATIONAL ACTION 2.0 - ECONOMY</u>

 <u>RAMON_STEVEN_MARBELLI</u>, Ingham, 8th April, 2011, seeking approval of the proposed Material Change of Use – Impact Assessment – From Quarry less than 5,000 tonnes to Quarry 5,000 tonnes – 100,000 tonnes of Lot 591 on FTY1586 at Broadwater Park Drive, Abergowrie State Forest. Land is zoned *Rural.* (058/0325)

<u>Resolved</u> – That the Development Application for Material Change of Use – Impact Assessment – From Quarry less than 5,000 tonnes to Quarry 5,000 tonnes - 100,000 tonnes be approved subject to the following conditions:-

- (a) The quarry access road intersection with Broadwater Park Road is to be upgraded to comply with the Hinchinbrook Shire Council's Standard, SD0025 *Typical Unkerbed Intersection Layout*, with works to be completed prior to the use commencing;
- (b) Prior to the use commencing the Applicant is to submit a proposal for Council's approval to install the upgraded signage at the quarry road access of Broadwater Park prohibiting public access;
- (c) Prior to the use commencing, the narrow single lane culverts at Chainage 2,300m and 5,100m to be upgraded to comply with the relevant section of the Manual of Uniform Traffic Control Devices (MUTCD);
- (d) Within six (6) months from the date of an approval, the Applicant is to enter a maintenance agreement in conjunction with Queensland Forestry Products (QFP) for the maintenance of Broadwater Park Road to Chainage 5,900m. The agreement is to be worked-up to require maintenance to appropriate public standards on a shared basis reflecting the respective share of haulage generation on the road;
- (e) The approval is for the extraction, screening and haulage of rock up to 15,000 tonnes annually. If the applicant extracts, screens or hauls, or expects to extract, screen or haul in excess of 15,000 tonnes per annum, the applicant shall prepare and submit to the Hinchinbrook Shire Council for consideration and approval a Road Impact Assessment (RIA) & revised Quarry Management Plan; and;

(f) Where it is determined in the RIA, as required by condition (e), or as otherwise determined by the Hinchinbrook Shire Council from alternative information sources, that haulage in excess of 15,000 tonnes per annum will increase the impact on the Council controlled road network, then the applicant may be required to make contributions towards road maintenance and/or future road upgrades.

<u>Resolved</u> – That the Development Application for Material Change of Use – Impact Assessment – From Quarry less than 5,000 tonnes to Quarry up to 15,000 tonnes be approved subject to the following conditions:-

- (a) The quarry access road intersection with Lannercost Extension Road is to be upgraded to comply with the Hinchinbrook Shire Council's Standard, R016 – *Typical Unkerbed Intersection Layout for 19m Semi-Trailer*), inclusive of under-drainage if required, with works to be completed prior to the use commencing. The works are to include a "*Give Way*" sign, installed in accordance with the Manual of Uniform Traffic Control Devices (MUTCD) guidelines at the location shown on the standard drawing above;
- (b) Prior to the use commencing the Applicant is to submit a proposal for Council's approval to install the upgraded signage at the private quarry road access off Durack or Woolley's Road (whichever is applicable) prohibiting public access;
- (c) Prior to the use commencing, the Applicant is to upgrade signage at narrow culverts at Chainage 8,175m and 8,500m to comply with the relevant section of the Manual of Uniform Traffic Control Devices (MUTCD);
- (d) Prior to the use commencing, the Applicant is to upgrade the section/s of Durack Road and Woolley's Road (if applicable) used for public road access to the pit, to comply with the Hinchinbrook Shire Council's standard Drawing ROO1 for "Rural Low Volume roads no Cane Traffic" i.e. 4.0 metre pavement on 5.0 metre formation (Type cross section Type 1A) and maintain in a condition suitable for the vehicle mass and traffic volumes using the public road section of this access;
- (e) The Applicant agrees to carry out any ordinary maintenance on Lannercost Extension Road between Chainage 7740m and Chainage 8600m in excess of a single maintenance grade per annum and the normal Hinchinbrook Shire Council program of scheduled maintenance (inclusive of re-sheeting as required, drainage maintenance and inspections) at the Applicant's cost;
- (f) Obtain a permit from the Hinchinbrook Shire Council prior to commencing any works on public road reserves under the control of the Hinchinbrook Shire Council;
- (g) Comply with the Department of Environment and Resource Management's advice agency response for referable wetlands;
- (h) The approval is for the extraction, screening and haulage of rock or other material up to 15,000 tonnes annually. If the applicant extracts, screens or hauls, or expects to extract, screen or haul in excess of 15,000 tonnes per annum, the applicant shall prepare and submit to the Hinchinbrook Shire Council for consideration and approval a Road Impact Assessment (RIA) examining potential adverse impacts on the Council controlled road network and a revised Quarry Management Plan; and
- (i) Where it is determined in the RIA, as required by condition (h), or as otherwise determined by the Hinchinbrook Shire Council from alternative information sources, that haulage in excess of 15,000 tonnes per annum will increase the impact on the Council controlled road network, then the applicant may be required to make additional contributions towards road maintenance and/or future road upgrades.
