Modification of Halifax Levee Project. Hydraulic Modelling

After visit by Mark Jempson (Venant Solutions) to Ingham, the following quotations were accepted

auav (drone Survey) \$4,560-00 + GST

Venant Solutions \$20,670-00 + GST

<u>Mitch Whittington Survey</u>, the Trust previously accepted his quote of \$5,400-00 + GST. He encountered very long grass and had to employ a labourer to help him do the survey lines. He has asked for a variation of + \$450-00 making his fee \$5,850-00 + GST.

I recommend that the Trust approve this increase.

The drone survey was completed and the data is with Venant Solutions

27th June. Meeting in Townsville called by DES to present the guidelines for the DRFA program – riparian recovery and weed and pest control.

Stage 1 component. Urgent Works and Reconnaissance Stage 2 component. Additional On-ground Works/Project Details

The project template was forwarded to the trust following the meeting by Terrain and the Dry Tropics NRM, and consulting engineers Neilly Group have now followed that up requesting the project sites and proposals from the Cairns, Cassowary Coast and Herbert Trusts so that they can coordinate proposals and prioritise them for the region.

The Trust needs to set its priorities to be submitted under this program at the July 4th meeting.

Applications close 15 July, 2019

2018/19 Resilience Funding, State Grants and Subsidies Program through QRA

The Trust's application went in by the 18th April, 2019 with funding for successful projects to be announced by the 30th June, 2019.

The Trusts project Herbert River restoration following flooding from the 2019 Monsoon Rainfall Event – river stabilisation works to reduce the risk of flooding and flood damage to urban and rural areas focussed on bank damage in the natural overflow channels of the Herbert and other streams e.g. The Anabranch, Halifax Washaway, Upper Stone (Lyons/Exelby area), Abergowrie (Porta and others area). Estimated project cost of \$500,000 with \$100,000 landowner contribution. Request 80% of \$400,000 or \$335,000 with the other 20% (\$65,000) to come from the Trust

Nothing has been heard from the QRA since.
