### **Modification of the Halifax Levee Project**

Application for Development Approval. Currently with DSDMIP Townsville.

DSDMIP referred the application for Concurrence Agency response to TMR, DNRME and also DAFF and DES. A meeting with officers was held 1/6/2020.

The Trust has now provided further information to the Assessment Manager, HSC. HSC will forward these responses to DSDMIP by Monday, 29<sup>th</sup> June.

#### Four responses:

- Marine Plant Survey a detailed assessment prepared by Michael Nash, Marine Biologist. Conclusion: No risk to marine plants.
- Levee crossing of State road (Halifax Bemerside Rd). Report prepared by Trust Engineer. No raising of spillway levels adjacent to the road is proposed.

Conclusion: Not considered that the increase in depth of 90mm or increase in velocity of 0.3m/sec on the road formation will increase severity of any flood damage in the road corridor.

- Quantities of fill required and change in footprint of levee. Report prepared by Trust Engineer. A detailed re-work gave 1,505m³ of fill or an average of 0.73m³/m. Increase in width of footprint varies but within 1m. Much of the levee is wide enough already to take an increase in level of 200mm and crest width of 700mm without increasing the footprint. It was always intended to increase the footprint on the town side of the levee in the part and open space areas.
  - 1,505m³ of fill to complete what will be a slow process of the raising the earth sections of the levee over say 8 weeks is 55m³/day, 5 or 6 body truck loads a day, or nothing compared to the heavy traffic through Halifax on the State road every day.
- Truck movements from the quarry to site. HSC has prepared a route plan from the Cordelia Mountain quarries to the site the obvious route Quarry Rd, Four Mile Rd, Musgrave St, town streets, Mona Rd.

I rang the QRA last week and provided an update on the project.


DSDMIP emailed the Trust again last Friday wanting the responses by 29 June 2020 and now payment of a further \$6,626. The Trust paid \$9,938 at the time of application.

# DRFA Stage 2 Projects – Stone R (SR-2), Herbert R (HR-2) and Waterview Ck (WVC-2) projects approved by DES 20/1/2020

Tenders were called in the Herbert River Express (17/6/2020) and Townsville Bulletin (20/6/2020) for each of the 3 projects. Tenders close on the  $16^{th}$  July 2020.

#### E. CORRESPONDENCE -

#### 1. LETTER FROM MR C BUTLER

Consideration of letter dated 11<sup>th</sup> June 2020 regarding the effects of the 2018 and 2019 monsoon events on the upper reaches of Cattle Creek, particularly in the area adjacent to Pettits Road and Lot 41 CWL83789 and Lot 40 CWL837588.

- The stream cannot function in a minor rainfall event and storm flows tend to leave the stream bed and travel across his farms
- Contractors were engaged to remove the build-up/blockages and cart the spoil away
- Would Trust members consider making a financial contribution to this work, as there is more to be done if Cattle Creek is to function properly and a contribution from the Trust would enable more cleaning work to be done downstream

For 600 metres, cost of cleaning is \$1 215 (ex GST) and carting is \$1 400 (ex GST) with there being another 1 kilometre to be cleaned with the same estimated cost.

**RESOLVED** – That the Trust approves the costs incurred to date, as a part of the 2020/21 Annual Works Program, and that the Trust Secretary advise Mr Butler in writing to provide the invoice to the Trust, for payment. That the Trust approves an additional 1 kilometre to be cleaned and the Trust will contribute a maximum of \$4 500 (ex GST) on presentation of an invoice and inspection of the completed works. #### 2. EMAIL FROM PETER LACEY (DEPARTMENT OF HOUSING AND PUBLIC WORKS)

Consideration of email received 11<sup>th</sup> June 2020 regarding the Queensland Procurement Policy (QPP). Executive Government has asked that it be updated bi-annually, with an emphasis on achieving 100 per cent application of the QPP for all agency procurement. To meet this request, the Trust's input is self-reported by completing a survey, which is to be completed by close of business on Wednesday 8 July 2020.
