# **Ripple Creek**

Relining of the 3.3m dia Armco pipes with the 3.1m dia poly pipe liners has been completed.

The pressure grouting completed and the 3 liners in place.

## The process included:

- cutting out the corroded sections that would prevent the liner from following the pipe cross section
- welding the 6m lengths together
- propping the liners to their circular dimension right
- adding spacers to ensure the void was even for grouting
- pressure grouting in layers to fill the interspace to the top.

The process was completed with the oversight of Mr Keith Phillips.

- earthworks
- rockwork
- levelling the top of the bank to ensure even overflows in the future
- seeding for early cover
- mulching the upper earth bank to facilitate the grass growth and prevent rutting from rainfall before revegetation.
