- C. MINUTES Confirmation of Minutes of the General Meeting held on 1 July 2021.

RESOLVED – That the minutes be approved. That the investigation regarding emergency generators for the flood gates with Lahtinen Electrical is ongoing and further discussions will be carried forward to the next meeting. (Cr AJ Lancini and Cr WG Skinner - carried)

D. WORKS REPORT – The Trust Engineer, Mr Tim Smith, provided an update of works for the month of July.

Engineer's Report

Modification of the Halifax Levee.

Construction for the raising of the levee has been completed. The detailed work to give the 3 properties in River Avenue equal flood immunity took time to complete with ongoing wet weather disrupting progress and the need to raise gateways and driveways.


Final inspection has been done.

The Trust is waiting for the QRA to pay the balance of their 80% contribution to enable the Trust to make the final payment to the contractor.

The "as-constructed" survey remains to be done and an EMP to be read as an addendum to the Hinchinbrook Shire Council EMP will be prepared.

Palm Creek bank stabilisation to protect Powerlink transmission tower, Cane Road.

Work completed and 100% contribution from Powerlink/Ergon received.



DRFA WVC-1 Waterview Creek (Clerk and other properties).

<u>Proposed works</u>: Supply, cartage and placement of 2,500 tonne select fill and 4,000 tonne graded broken quarry rock. Revegetation above the rock in gaps in the existing vegetation to follow.

The proposed works will repair bank erosion at sites in the Clerk, Marmarella, Rapisarda and Russo properties on Waterview Creek. Approval was received from DES Brisbane DRFA Assessment Panel on the 17 July 2021 to extend the scope of the works to include bank erosion sites in neighbouring properties.

Tenders were called 19 June 2021 and closed 8 July 2021. 5 tenders were received. An assessment of tenders and a recommendation has been prepared for the 5 August 2021 meeting.

Disaster Assistance Grants – Primary Producers - 2021 weather event Tropical Cyclone Niran and Associated Low Pressure System 25 February - 3 March. Grants through QRIDA.

Requests for assistance with applications and Herbert River Trust oversight of works on riverbanks continued to come in. Herbert River below the highway, Anabranch, Lottery and Ripple Creeks and Sandy Creek at Abergowrie. Inspections have been carried out and letters/reports prepared for each to support applications for works on river and creek frontages.

To date, these letters/reports have identified about \$650,000 in bank repairs needed to restore traffic ability on headlands for farm machinery and haul outs.

The Trust proposes that the establishment fees be borne by QTC and that any loan triggered by use of the facility be interest free.
