Engineer's Report

Modification of the Halifax Levee.

Construction for the raising of the levee has been completed.

The "as constructed" survey has been done by Atkinson Surveys.

The survey doesn't include the cross-sectional views of the private levees – to confirm the height and location of the private levees to allow the dimensions to be compared with those assumed in Venant Solution's flood impact assessment.



DRFA WVC-1 Waterview Creek (Clerk, Mammarella, Rapisarda, Russo properties).

Work is completed in the Mammarella, Clerk, Rapisarda and Russo sections.

Keita Services Pty Ltd completed the work under the contract and the additional work they were directed to do around the boundary of the Rapisarda and Russo properties.

Project 95% completed. Revegetation remains to be done.

Disaster Assistance Grants – Primary Producers - 2021 weather event Tropical Cyclone Niran and Associated Low Pressure System 25 February - 3 March. Grants through QRIDA.

One request for assistance with application and Herbert River Trust oversight of works on riverbanks was addressed – Ripple Creek – bank damage affecting traffic ability of farm headlands.

Lagoon Creek at Fourmile Road (T Poppi).

Assistance was requested to get the table drain reformed in the last 50m before the rocked outfall into Lagoon Creek. Mr Poppi said the road table drain was unknowingly filled during road maintenance work and now the table drain ponds and drains very slowly through a 375mm cross drain culvert back at the guideposts 200m back from the creek. He says the situation is waterlogging his paddock.
