2. BANK REPAIRS – SEYMOUR RIVER AND RIPPLE CREEK

Consideration of correspondence dated 19th November 2014 from L. Mrs A and CS Cristaldi regarding HRIT advice (22nd December 2011) that damages were eligible for Natural Disaster Recovery repairs and that to date the repairs have not been commenced and that the works on their property could be conducted in conjunction with the rehabilitation work on the Herbert River, which has commenced.

Consideration of correspondence from The Hon Andrew Cripps MP making representations on behalf of Mr Guido and Mrs Coral Rizzalli of 9 Maria Court, Ingham regarding Mrs Rizzalli's concern that trees are falling in to the creek from the river bank, which may create obstruction in the water course which could impact surrounding properties in the event of heavy rain. An on-site inspection by HRIT members and consideration to clear the debris is requested.
