Consideration of letter dated 26 April 2013 advising that he is prepared to remove part of the levee bank before 2013/2014 wet season, after the adjacent area has been harvested and that he wishes to maintain part of the bank where the flood water is a serious problem and will cause considerable damage. (101/0002)

<u>Trust Engineer's Comment</u> – This letter is in response to discussion with the Trust on site in February 2013 and our follow up correspondence. Mr Kemp has offered to remove part of the levee only at Lot 92 on CWL433 (Southern bank of Ripple Creek immediately upstream of Gangemis Road, Hawkins Creek).

 $\underline{\mathsf{Resolved}}$ – That the Trust provide a response to the landowner acknowledging receipt of his letter and await the outcome.

Terrain will be applying to the Reef Rescue package Round 2 - Trust Engineer to meet with M Nash to discuss which works may be given priority for funding and will bring that information to the next Trust meeting.

The Expression of Interest for Palm Creek item did get accepted.

6. <u>DEPARTMENT OF NATURAL RESOURCES AND MINES</u>

Advising that the Federal Government have allocated some NDRRA Category D Exceptional Disaster Assistance Scheme funds for certain measures and programs to help Queenslanders recover from TC Oswald and the associated weather events. In the Category D arrangements there is a program of \$10M allocated for environmental recovery. Advising that this is an opportunity for local River Trust bodies to lobby their local NRM bodies to approach the DNRM Committee to consider allocating some funding to their areas. (011/0007)
