4. THE HON ANDREW CRIPPS MP

Consideration of correspondence dated 28 June 2013 advising that further to a meeting held with Department of Natural Resources and Mines (DNRM) Officers on 13 June 2013 DNRM contacted Queensland Reconstruction Authority (QldRA) seeking advice on the application of the eligibility criteria for Restoration of Essential Public Assets and QldRA is now preparing advice to DNRM, further DNRM provided QldRA with the Trusts submission for NDRRA funding for the 2011 Tropical Cyclone Yasi declared event for assessment under the Commonwealth Determination.

5. DEPARTMENT OF NATURAL RESOURCES AND MINES

- · Cleaning of Ripple Creek, including some re-vegetation;
- Cleaning of Lannercost Creek from Lannercost Extension Road to the mouth, including some re-vegetation.
