MAHONY AND SONS

Consideration of correspondence dated 2 August 2013 advising of a potential problem at the river bank, just down stream of the Halifax Washaway, where a slump approximately fifty metres long, previously rock battered, has eroded away by current and seeking an inspection and repairs to the area. (103/0003)

Advising that a Regulation of Levees in Queensland: Consultation Regulatory Impact Statement has been prepared to support ways in which the regulation of levees will be implemented and seeking feedback from the Trust to include:-

- Who should be the assessment manager for levees
- How levees will be categorised
- The assessment requirements for each category of levee
- How to regulate modifications to existing levees

Submissions should be made in writing and sent to the Department by 5pm on 6 September 2013.

Consideration of correspondence dated 18 July 2013 inviting the Trust to participate in a Testing Group to assist DNRM in developing an Assessment Code as part of the proposed regulation of levees in Queensland. Ten Councils throughout the State are being invited to take part.

Discussions with the Testing Group are planned to commence in early September after consultation on the RIS is completed and that is when they will seek advice on the workability of the codes and guidelines.
