#### 7. <u>BURNSIDE (INGHAM) PTY LTD</u>

Consideration of correspondence dated 4 November 2013 regarding a river embankment washout on his farm at 192 Capras Road, Abergowrie seeking the Trusts permission to extend and follow the river's natural flow, which has been altered due to an island having developed in the middle of the river. As the Trust are unable to fund these works, he is willing to try fund the job. Would like to complete before the wet season. (103/0003)

<u>Resolved</u> – That the Trust advise that unfortunately the channels have been constructed in this area in the past and have proved not to be a long term solution therefore the Trust is not able to endorse your proposal, but instead feels more comfortable with the proposal suggested by Tim Smith as a long term solution to the issue of bank stabilisation. (*Mr Phillips and Cr Skinner – Carried*)

#### 1. INSPECTION OF MAHONY PROPERTY, HALIFAX

Discussions were held regarding an inspection of Bruce Mahony's property at Halifax conducted on Monday 28 October 2013.

<u>Resolved</u> – that the Trust request Mark Jempson to model the impacts of removing the natural levee that has formed on the northern side of Halifax Road just to the east of the Four Mile Road intersection near the Halifax washaway.

Resolved – that the Trust request Mark Jempson to model the impacts of removing sand islands from the Herbert River as per the Preliminary Lower Herbert Sand Island Removal Proposal provided by the Trust Engineer dated 9 September 2013. (Cr Carr and Skinner – Carried)
