## HERBERT RIVER IMPROVEMENT TRUST

### GENERAL MEETING MINUTES

THURSDAY 15 NOVEMBER 2012 AT 9.00 AM



- A. <u>ATTENDANCE</u> Present were Mr WH Pickering (Chairperson), Cr WG Skinner (Member), Cr DG Carr (Member), Ms Leanne Mash (Trust Secretary), Mr BE Leach (Trust Engineer) and Mr S Hall (Trust Works Manager).
- B. <u>APOLOGY</u> An apology was received from and Michael Nash (Catchment Coordinator and Acting Terrain NRM).
- C. <u>MINUTES</u> Confirmation of Minutes of the General Meeting held on 4 October 2012.

<u>Resolved</u> – That the minutes of the General Meeting held on 4 October 2012 be approved. (Councillor Carr and Mr Pickering - Carried)

#### D. WORKS REPORT -

Consideration of Trust Engineer's October 2012 report of works performed to date and activities in progress.

Pre-season checks for Halifax Levee have been carried out. Honda pumps have been serviced and returned in good order ready. Jeff Lahtinen contacted and currently servicing electric pumps. Works Manager will contact Paul Britton to carry out pre-season checks on flood gates.

Finance Manager C Trost entered the meeting at 9.15am

Contractor engaged to remove two trees impacting on River Avenue Levee next week.

Trust Engineer and Trust Chairperson met with Old Wharf Road landowners regarding washout and Chair made decision to fix it. Plans are yet to be finalised and Brad Simmonds will carry out some of the works. Chair advised that what occurred is unfortunate and landholders were positive.

No formal word has been received regarding NDRRA Assistance. Timely Preventative Works (TPW) have commenced at Log / Palm Creeks and they are 75% complete. The works behind the Ingham Kindergarten are complete and will be under estimate which will leave TPW money to divert to other ones.

Ripple Creek floodgate plot we have received quotes and suggest this work be carried out prior to next wet.

Detailed designs for Critical Water Course Riparian and Beach Recovery completed and submitted to Terrain last week / early this week. Preconstruction phase to be carried out now and scope to be pitched to the amount of money received. Will work through (kick off next week) and try to get jobs done.

Pre-season checking will commence shortly for the Automatic Lift Gates.

Halifax levee budgeted to receive up to two thirds funding but only received 10% (waiting on in excess of \$100,000) and hoping to receive two thirds of total cost.

Precept has been submitted. There is \$35,644.40 owing for the Lower Herbert Flood modelling.

Discussions need to be held with Bruce regarding landholder contributions and whom we need to refund.

No costs incurred so far on Annual Works Program. Still waiting to see if we can access funds from Terrain.

Finance Manager C Trost left the meeting at 9.40am

#### F. OFFICE OF THE QUEENSLAND OMBUDSMAN

Consideration of discussions in relation to the Ombudsman's ongoing investigations with Department of Natural Resources and Mines regarding the Trust's Cyclone Yasi NDRRA claims.

Feedback has been received that indicates that there is no ready progress on the matter.

Trust Secretary held discussions with David McIntyre of Ombudsman's office. His investigations to date have revealed there is no clear way to progress this matter. The Trust Engineer has been advised by DERM continually that when the new guidelines are released the matter will be resolved however there is still no outcome and no determination.

Cr Skinner entered the meeting at 9.45 am

#### 2. STATE COUNCIL OF RIVER TRUSTS' ASSOCIATION

#### 3. STATE COUNCIL OF RIVER TRUSTS' ASSOCIATION

Consideration of correspondence dated 24 October 2012 advising the State Council Executive has determined the distribution of grant funds for the 2012 / 2013 financial year based on each Trusts' annual works program submitted which is \$230,000 plus a carry over of \$59,811.58 from last year's grant. Grant funds available to the Herbert River Improvement Trust for 2012 / 2013 are \$24,500. (102/0001)

#### 4. DEPARTMENT OF NATURAL RESOURCES AND MINES

Consideration of correspondence dated 24 October 2012 advising the Director General recently approved the Trust's Annual Works Program for 2012 / 2013 and forwarding approved Annual Works Program Schedules A and B. Further advising the Department has only sought "in principle" consent and approval for the Annual Works Program and requesting the Trust to note that while the Annual Works Program has been approved, it must ensure that all necessary technical approvals are obtained prior to any works commencing. The Department will shortly finalise the State Grant Contract with the State Council of River Trust's Association and the Association Secretary will contact the Trust soon after regarding the distribution of these grant funds. #### 5. DEPARTMENT OF NATURAL RESOURCES AND MINES

Consideration of correspondence dated 25 October 2012 advising the Department has been working with Queensland Treasury and Trade and the Queensland Audit Office to develop guidelines to assist the Trust to meet its obligations under the *Financial Accountability Act 2009*. Until recently all Trusts were exempted by the Treasurer from complying with certain provisions of the Financial and Performance Management Standard 2009 (FPMS) and these exemptions now no longer apply to Trusts meaning that full compliance must be achieved for 2012 / 2013 and beyond. The most relevant provisions of the FPMS are categorised as "governance" and of these governance obligations, those relating to "asset management" have been identified as requiring special attention, particularly in relation to the achievement of consistency in Trusts' reporting to the Queensland Audit Office. Forwarding copy of *Guidelines for Compliance – Finance and Performance Management Standard 2009 - section 23: Asset Management.* (104/0001)

#### H. <u>SESSION WITH HERBERT RIVER CATCHMENT COORDINATING COMMITTEE</u>

Consideration of discussions held with Terrain NRM, Jacqui Richards regarding proposed Catchment group activities for which support by the Trust would be welcomed.

The Trust noted Michael Nash's apology.

The Trust noted that Terrain MRM are lodging an Expression of Interest with the Bio-Diversity Fund for Palm Creek. It is the first Federal grant targeted at northern Australia. Mungalla has a 1.4m bund wall and will be removing it this time next year to let saltwater in for Hymenachne and seek the Trust to participate as a project partner in this proposal.

There is a slew gate at Victoria Mill to reinstate natural flows there which is a good fish passage for Barramundi up the creek.

Should Terrain be successful with its EOI they will then approach all landholders from Mungalla back to Sucrogen dam wall.

DERM are going to be submitting a Cattle Creek application through Catchment Group also.

It was noted that the Trust is not directly involved with this application.

#### I. FURTHER MODELLING FOR LOWER HERBERT –

The Trust returned to the Work's Engineer's Report Item for further modelling for Lower Herbert (risk analysis for Halifax Levee).

Working on estimate for Herbert Flood Investigations. Estimate of works at Halifax Washaway is \$15,000. Both are about \$15,000 + \$5,000 every time BMT WBM come up (\$25,000 all up). The issue is the levee was designed for a 1 in a 100 year flood but it is now overtopping. Main issue is we need to do this analysis then it will come up with something but we may not be able to do it, we may have to take it away but that may change the current balance. We wouldn't do that until we've done another analysis though. We would then do a study to disbenefit other people on the river and it may be that we need additional shoots. If the slope has changed it might require we have to put in another spillway, it will reduce the benefitted area of the levee. The flood grade has changed and it proves there is a lot of leveeing occurring upstream ie levee growth upstream makes more flood water for Halifax.

Level of protection is about 1 year – has been overtopping and concern is that it could overtop again and cause failure – need to do analysis to reduce risk ensure there is no damage to property or lives –

Option could be to increase spillway – even if we wanted to raise levee we have to do a risk analysis

<u>Resolved</u> – That the Trust proceed with additional modelling studies for the Lower Herbert. (*Mr Pickering and Cr Carr - Carried*)

Concern was steepness of levee on other side – Trust Engineer agreed to make it the same as the other property.
