## B. <u>GENERAL BUSINESS</u> -

Consideration of revision of the Annual Works Program.

 $\underline{\text{Resolved}}$  – That the Trust amend the Annual Works Program and complete new Form B's to reflect the inclusion of the critical watercourse projects not funded by the special allocation and also the addition of Mr. Alf Di Bella – Palm Creek Project - as the landowner is funding the total project cost.

That the Trust adopt the following scale of landowner contributions as a pre-requisite to the Trust carrying out the projects:-

That for the 2011 / 2012 Annual Program, landholder contributions be capped at \$25,000.

That in relation to the Vitale – Ripple Creek Project - no landholder contribution is required as the works will protect the road which provides access to the floodgate. (Mr. Pickering and Cr. Lynch - Carried)

Consideration of rock works at Mahony property at Halifax and the level of rock works in relation to the existing height of the Trust's Halifax Levee work.

<u>Resolved</u> – That the landowner be required to reduce the work to the levels pre-existing at the completion of the Halifax Levee.

That a Section 11 Notice be placed to protect the level spreader Trust asset work. (Cr. Gianotti and Mr. Pickering - Carried)

Consideration of proposed NDRRA works – earth mound on Herbert River just north of Taylors Beach Road.

<u>Resolved</u> – That the earth mound be repaired as a Trust asset under NDRRA. (Cr. Lynch and Cr. Gianotti - Carried)

## D. <u>CORRESPONDENCE</u> –

1. <u>W. TENTO</u>, 28<sup>th</sup> November, 2011, requesting the Trusts urgent attention to cleaning Swampy Creek in the area where it crosses Taylor's Beach Road to mitigate effects of flooding in the area.

<u>Resolved</u> – That the requested work appears not to be the Trust responsibility and the Trust inspect the area for further consideration in January, 2012. (Cr. Lynch and Cr. Gianotti - Carried)
