Explanation Notes

Tuition Fees

This fee, charged per student per year, supplements funding for ongoing College operating expenses, including wages and utilities. The rate is reviewed annually by the Diocese. Discounts apply if you have more than one student attending Catholic Schools in Cairns Diocese.

Resources Levy

This levy is charged by the college to cover a wide range of student resources including and not limited to a student laptop (Including Insurance, hardware, software, maintenance, and IT support), online subscriptions, classroom consumables and resources, lockers, subject and library resources. Resources levy also includes elective fees for the general elective subjects that a student selects.

Activity Levy

The levy is charged per student to cover the cost of student activities throughout the year, which includes school camps and retreats, classroom excursions, sports carnivals, art productions and other elective activities.

Capital Levy

An annual levy charged per family to contribute to the capital costs of school infrastructure such as repaying loans for new buildings and raising funds to enable continuous building works and improvements

Families at Newman Levy

An annual levy charged per family on behalf of P & F Committee. It provides a consistent source of funds which the F@N in turn uses to assist with the costs of College endorsed functions, activities and minor capital purchases

Other Charges

Apart from the above, families will need to budget for other charges, such as uniforms and compulsory book packs and any other charges depending on the students' involvement in extracurricular activities. These charges will be invoiced to families as the year progresses, and may include the following:

- Bus Transport Charges
- Instrumental Music fees
- Some elective subjects – Please refer to electives handbook for the respective charges
- Laptop damage fee
- Excursions that are not part of the curriculum (Extra curriculum activities)
- Interstate and/or Overseas trips.

Discounts and Concessions

Discounts on the Diocesan *tuition fees* apply for families with two, three or more students attending a Catholic primary and/or secondary school within the Cairns Diocese. Further discounts are available to holders of certain categories of Health Care and Pensioner Concession Cards, and to families experiencing genuine financial hardship upon completion of the confidential fee concession application form and engagement with the College.

Refund of Tuition Fees and Levies

As per Clause 13 of the confirmation of Enrolment Agreement, a 10-week term time notice in writing must be given before withdrawal of a student. Failure to give such notice will involve payment of the fee for the relative billing period, irrespective of the date the student may leave during the term. Exceptions may be given in cases of transfers at short notice, or on compassionate grounds.
