1. Welcome and Introduction of new members

New people were welcomed to today's meeting – Nina Henney from DEHP, Don Neale from DSITI, Melissa McKeown from TCC, Tracey Bauer from South32.

Apologies were noted.

The Chair addressed the group with a statement regarding the tasks and future ambition of the PSWG:

We as a working group have an important and complex job ahead of us. After speaking to almost all those around this table since our last meeting, it's apparent there is a shared desire to:

- better inform our community about environmental performance here at the Port by ensuring people have accurate and factual information about issues relating to air quality, dust deposition and environmental management practices,
- to support and stimulate improvements to performance,
- and to contribute to making Townsville a better place to live and work.

To achieve these outcomes we have agreed to work together, sharing information, discussing it and reaching consensus. This working together has to be based firmly on trust to ensure that everyone here - individuals or organisations - are able to present and discuss sometimes complex or confidential information without fear of misinterpretation or misreporting. We all have a role to play in ensuring that this group becomes neither a "talk fest" nor a mere exchange of polished public documents.

As Chair, my message is clear – the train is moving and everyone has a choice to be fully onboard or standing on the station waving.

2. Minutes of previous meeting

3. PSWG Community Reps port tour

- Clive Berger, Judy Newman, Ian Ferguson and James Hobbs expressed their appreciation at being given the opportunity to tour the Townsville port. Feedback included (paraphrased):
 - The construction work that has gone on over the last few years was interesting to see – it's pretty massive, James Hobbs
 - I used to work here on the cranes and it's extraordinary to see the changes and size of land reclamation and how much has gone on in general recently.
 Lots of construction would be part and parcel with the problem (dust emissions), I'd imagine, Ian Ferguson.
 - Before September 11 we used to be able to drive through the port so it was interesting to see all the changes that have gone on since then, Judy Newman.
 - Clive Berger asked if the Cannington conveyor belt was enclosed and Graeme Nielsen confirmed this.
 - Wendy Tubman has also had a tour of the Glencore facility since the last PSWG meeting.

5. DEHP Report

- Chris Wake provided an update on the installation of near real-time monitoring at the
 port. Installation of the new monitoring equipment is due to take place between the
 middle and end of July, after which time a commissioning and calibration process will be
 undertaken. It is estimated this process may take up to three months. Data obtained
 from the near real-time monitoring will be made public once the new equipment is
 operating correcting.
- Chris advised that correct protocols to make contact with DEHP to report incidents or make a complaint was by phone or email to – so that it can be correctly recorded. Chris noted that he was still happy to field enquiries however the standard procedure was preferred.
- Chris addressed a previous query from Wendy Tubman regarding sampling and particle size. Chris presented an explanation to the group that TSP standards and measurements are defined sample particles within a size range. More information around this definition is available in David Wainwright's (DSITI) presentation from the last PSWG meeting.
- The group was reminded that an explanation of the different types of sampling equipment is available on the Port of Townsville website.

6. DSITI Report

Chris Wake also provided an update on behalf of DSITI and advised that work was underway with the QLD Chemical Centre to investigate the different methodologies between the old standard and the new standards. DEHP are reviewing some of the monitoring data and licences that are in place at the

port for port users. At present they are still waiting on some data (from port users) to be able to complete this task - this is expected to be received by the end of June 2015.

7. Queensland Health Report

- Damien Farrington advised he would make available Queensland Health issues/complaints contact point.
- Clive Berger had a question for QLD Health about why children are not routinely tested for blood levels if there is concern in the community. Damien advised that Queensland Health had no ability to compel blood samples from children and that volunteer programs in other places had been not very successful. He noted that people do not volunteer their children for blood testing or the volunteers that are willing aren't from higher risk demographic groups, thus potentially skewing any data gained. In Mount Is a there was a public health intervention triggered when information from other sources that indicated there was likely to be a problem.
