This will include bow sprits, davits and any extruding platforms.

- The Berthage Monthly Rate applies to Vessels approved to occupy a berth for periods in excess of one calendar month, with charges payable monthly in advance and includes berths occupied under long term Commercial Berth Agreements which provide for Berth Charges to be determined on review in accordance with the Schedule of Charges




