

## **Energy Tariffs and Associated Charges as of 1 July 2025**

The tariffs applied to the on-supply arrangement are in-line with the local area retailer's standing offer (Ergon Energy). **The following tables are consistent with the Gazette dated 6 June 2025.**

### **Small business tariffs**

Available to customers using 100 MWh per annum or less

#### ***Tariff 20 Small Business flat-rate primary tariff***

This tariff is the most common tariff for small businesses. You pay for what you use at a flat rate throughout the day and night, plus a daily supply charge.

| <b>From 1 July 2025</b> | <b>Ex GST</b> | <b>Inc GST</b> |
|-------------------------|---------------|----------------|
| All usage per kWh       | \$0.32364     | \$0.35600      |
| Daily Supply Charge     | \$1.82791     | \$2.0107       |

### **Large business tariffs**

Large businesses tariffs are designed to meet the unique energy needs of our large business customers, using more than 100MWh per year. Customers have the option to switch between large business tariffs once in a 12-month period.

#### **Demand tariffs**

All our large business tariffs are demand-based. On a demand tariff, you're charged for the total amount of electricity you use plus a demand charge and a daily supply charge.

Your electricity demand is based on your highest electricity use in a 30-minute window during the month. When you choose a demand tariff, your whole business must be connected to that tariff.

#### ***Tariff 44 Large business monthly demand primary tariff***

This tariff has a charge for the total amount of electricity used plus a demand charge for the relevant billing period and a daily supply charge.

The demand threshold under this tariff is 30kW/35kVA.

| From 1 July 2025     | Ex GST     | Inc GST    |
|----------------------|------------|------------|
| Demand Charge per kW | \$29.47300 | \$32.42030 |
| Demand Charge kVA    | \$26.52400 | \$29.17640 |
| All usage per kWh    | \$0.19093  | \$0.21002  |
| Daily Supply Charge  | \$47.30570 | \$52.03627 |

***Tariff 45 Large business monthly demand primary tariff***

This tariff has a charge for the total amount of electricity used plus a demand charge for the relevant billing period and a daily supply charge.

The demand threshold under this tariff is 120kW/135kVA.

| From 1 July 2025     | Ex GST     | Inc GST     |
|----------------------|------------|-------------|
| Demand Charge per kW | \$29.19600 | \$32.11560  |
| Demand Charge kVA    | \$26.27600 | \$28.90360  |
| All usage per kWh    | \$0.19100  | \$0.21010   |
| Daily Supply Charge  | \$150.7247 | \$165.79713 |

***Tariff 46 Large business monthly demand primary tariff***

This tariff has a charge for the total amount of electricity used plus a demand charge for the relevant billing period and a daily supply charge.

The demand threshold under this tariff is 400kW/450kVA.

| From 1 July 2025     | Ex GST      | Inc GST     |
|----------------------|-------------|-------------|
| Demand Charge per kW | \$28.58900  | \$31.44790  |
| Demand Charge kVA    | \$25.73000  | \$28.30300  |
| All usage per kWh    | \$0.18607   | \$0.20468   |
| Daily Supply Charge  | \$394.72650 | \$434.19915 |
