The Committee is delighted to report that in the twelve months since its last Annual Report an additional 47.06 per cent of total measures are now completed measures, and a total of 87.25 per cent of total measures are now completed or in progress.

The Committee can also report that 77.95 per cent of the Two-Year benchmark outcomes articulated in the White Paper have been achieved.

This is an outstanding result.

I would like to thank the members of the Committee for their commitment to ensuring the people of Northern Australia have an effective voice in developing the North.

I would also like to thank all Ministers and departmental personnel who have applied themselves and their departments to the implementation of the White Paper with great enthusiasm.

The Committee looks forward to the next phase of Northern Development policy.

Introduction

- 1.1 The *Our North, Our Future: White Paper on Developing Northern Australia* (the White Paper) was announced and released on June 17, 2015 by then-Prime Minister the Hon Tony Abbott MP. The formation of the *Northern Australia Oversight Committee* (the Committee) was announced by the then-Prime Minister on the same day.
- 1.2 This is the Committee's second Annual Report to Government.
- 1.3 The Committee was created as a committee of Government.
- 1.4 The Committee's membership comprises Government Senators and Members from and/or representing Northern Australia. The current members are:

• Senator The Hon Ian Macdonald (Queensland) (Chair);

• Senator Barry O'Sullivan (Queensland);

• Senator Dean Smith (Western Australia);

• Senator The Hon Nigel Scullion (Northern Territory);

• Mr. Ken O'Dowd MP (the Member for Flynn);

• Mr George Christensen MP (the Member for Dawson);

• The Hon Warren Entsch MP (the Member for Leichhardt);

• Ms. Melissa Price MP (the Member for Durack); and

• Mr David Littleproud MP (the Member for Maranoa);

1.5 The original membership of the Committee also included the then-Member for Solomon Ms. Natasha Griggs MP, the then-Member for Herbert Mr. Ewen Jones MP, and the then-Member for Maranoa the Hon Bruce Scott MP, and former Senator for Western Australia Chris Back. The Committee thanks Natasha, Ewen, Bruce and Chris for their unique insights and strong advocacy

for the development of Northern Australia both as Northern Australian parliamentarians, and as members of the Committee.

- The Committee's Terms of Reference (ToR) were settled on August 18th, 1.6 2015 following consultation with the office of the Prime Minister. The relevant ToR are as follows:
 - The Northern Australia Oversight Committee will monitor the implementation of the White Paper on Developing of Northern Australia and play a key role in keeping Ministers and officials honest on delivery of actions in the White Paper.
 - 2 The Committee will report directly to the Prime Minister and the Deputy Prime Minister. (NB: the latter in his then-role as the relevant Minister for Northern Australia) An annual report will be provided to inform an annual statement to Parliament by the Deputy Prime Minister (NB: this annual statement to the Parliament is now delivered by the Minister for Northern Australia).
 - 4 The Committee will be able to request written information and request oral evidence from Ministers responsible for various elements of the White Paper and officials from their departments. Ministers have been asked to ensure their officials engage constructively with the Committee.
 - 5 The Deputy Prime Minister will arrange for updates from the Office of Northern Australia on progress with the White Paper including at least three meetings with the Office of Northern Australia every calendar year.
 - 6 The Oversight Committee will also interact with proponents of submissions and proposals made as a result of the White Paper, and will liaise on behalf of the Government with people and entities of Northern Australia on the implementation, and provide feedback to relevant Ministers and departmental officials.
- 1.7 The Committee was created to augment the Government's Northern Australia policy architecture. The primary purpose of the Committee is to scrutinize the implementation of the measures detailed in the White Paper and address, within Government, any deficiencies in that process.

- 1.8 In contrast, the Joint Select Committee on Northern Australia - which under the auspices of the Northern Australia White Paper has now become the Joint Standing Committee on Northern Australia (JSCNA) - chaired by the Hon Warren Entsch MP was formed as a parliamentary committee with a wide remit to inquire into and report on issues relating to Northern development generally. The Committee welcomes the decision of Government to re-form the JSCNA as a permanent standing committee of the Parliament.
- 1.9 In accordance with the Committee's Terms of Reference (ToR clause 6) the secondary purpose of the Committee is to give a voice to the people and communities of Northern Australia and to ensure that their insights and objectives are properly represented in the development of Northern Australia.
- 1.10. The inaugural meeting of the Committee took place on August 19th, 2015. The Committee has met subsequently as required.
- The Committee supports the creation of the Northern Australia portfolio as an essential element to the development of the North. Cleary, however, many of the commitments and funding in the White Paper are within the jurisdiction of other Ministers, particularly within the Indigenous Affairs, Agriculture and Water, Trade, Infrastructure, Employment, Education, and Environment portfolios.
- The Committee appreciates that the breadth of work required to deliver Northern Australian development and notes the importance of independent monitoring, within Government, of the implementation of the White Paper.
- 1.13 The Committee has sought regular updates from Ministerial offices regarding the implementation of the measures in the White Paper and has been reassured by the willingness of Ministers and their staff to provide these updates where possible. The Committee does, however, acknowledge the workload of Ministers and their staff and is cognizant that the Committee's requests for updates do not always coincide with the relevant information being available.
- The Committee most recently wrote to relevant Ministers in May 2017 to re-iterate the Committee's on-going commitment to monitoring and encouraging the effective implementation of the White Paper, and to seek updates on progress.
- The Committee acknowledges the Minister for Northern Australia's first statement of progress to the Parliament on Tuesday October 11, 2016, and

anticipates that the Minister will provides a subsequent statement to the Parliament later this year (2017).

1.16 The Committee notes a general perception encountered across the North that there has been a 'softening' of momentum and that progress on Northern development has slowed. The Committee does not agree with this view and believes that the data presented in this Annual Report disproves the perception.


Progress Report


- 2.1 The Committee notes that the Department of Industry (within which portfolio Northern Australia Development sits) recognizes a total of fifty-one (51) White Paper commitments. The Committee, however, recognizes one hundred and two (102) (see Appendix A).
- 2.2 The Committee is delighted to report that in the twelve months since its first Annual Report in September 2016 an additional twenty-nine (29) of the one hundred and two (102) commitments detailed in the Northern Development White Paper have been completed.
- 2.3 The 102 commitments recognized by the Committee extend beyond the financial and specific regulatory measures detailed in the White Paper, and include all commitments to action: some have budget appropriations, some are changes to policy settings, and others are statements of intention that reflect the Federal Government's methodology for enabling the development of Northern Australia. The Committee acknowledges that some commitments are so closely aligned as to invite concurrent consideration. However, the Committee elected early in its lifespan that its 'oversight' remit would be best served by tracking the progress of each item individually. It is the Committee's view that proper oversight of the implementation of the White Paper includes the monitoring of all statements of action and intention.
- 2.4 As at August 1st, 2017 the Committee has identified that:
 - Forty-eight (48) of 102 commitments in the White Paper are completed;
 - Forty-one (41) of 102 commitments in the White Paper are in-progress;
 - Eleven (11) of 102 commitments in the White Paper are not actioned; and,
 - Two (2) of 102 commitments in the White Paper are abandoned/discontinued (the White Paper on the Reform of Federation, and the Regulation Repeal Day 2016)

2.5 The percentage of progress on committments across the entire White Paper from 2016 to 2017 is as follows:



Analysis

- 3.1 The six-theme format of the White Paper (Land, Water, Trade, Infrastructure, Workforce and Governance) allows individual commitments and initiatives to be understood in context of a broader policy framework. Attention is often directed at the large-scale catalytic commitments in the White Paper, and the impact that these measures will have on employment and economic activity. The Committee is mindful, however, that the potency of the White Paper lies in the interaction between its substantial funding commitments, and its less notable, but nonetheless transformative, changes in policy settings.
- 3.2 The Committee is pleased to note that in all six of the thematic areas of the White Paper the progress of the deployment and completion of measures has remained strong. It is noteworthy that the combined total of 'Completed' and 'In Progress' measures was 68.63 per cent of all measures in August 2016, and is 87.25 per cent of all measures in August 2017. This increase indicates that, overall, the number of White Paper measures to have been activated - to any degree - has grown steadily over the past twelve months.

- 3.3 The Committee is also pleased to note that the overall number of measures classified as 'No Action' has reduced from 29.41 per cent of total measures, to 10.76 per cent of total measures. This would indicate that individual departments are maintaining a rate-of-work through the commitments relevant to their portfolios. The Committee notes that half of the persisting 'No Action' measures are related to land tenure and are therefore reliant upon collaboration between Commonwealth, State and Territory Governments and as such sit outside the direct control of the commonwealth government. These land tenure measures are discussed further in paragraphs 3.4 to 3.7 below.
- 3.4 The <u>Land</u> section of the White Paper was identified in the Committee's 2016 Annual Report as an area of concern due to the apparent lack of progress on the commitments in that section at that time. In August 2016 no commitments in the Land section had been completed, and almost half had attracted no activity at all. In the 2016 Report the Committee recommended that renewed leadership and guidance be applied by the Executive to the White Paper's Land commitments, particularly in relation to the measures relating to native title and Indigenous Affairs.
- 3.5 The overall progress in the Land section over the ensuing twelve months has been positive, with 30 per cent of the Land commitments now completed. The Committee acknowledges that much of this completion-rate has been achieved in the Indigenous Affairs portfolio.
- 3.6 Despite this improved completion-rate, the 'No Action' percentage in the Land section remains high at 30 per cent which is the highest 'No Action' percentage across all six thematic streams. The bulk of these 'No Action' commitments relate to pastoral leases and land tenure. The Committee acknowledges that these issues are within the jurisdiction of State and Territory Governments and, as such, require a collaborative approach between the Commonwealth and the governments of Queensland, the Northern Territory and Western Australia. The Committee recommends that progress on these issues be pursued through the Strategic Partnership created under the auspices of the White Paper (comprising the Prime Minister and the Chief Ministers of Queensland, the Northern Territory and Western Australia), and/or through COAG.
- 3.7 The six (6) commitments in the Land section of the White Paper that, after two years, have not received any attention are:

- Bring forward the point at which leaseholders can apply for renewals (White Paper page 38);
- Introduce template leases for large capital investments (e.g. 100 years) (White Paper page 38);
- Transfer control of 'inputs' to other legislation (White Paper page 38);
- Redistribution of compensation costs to prospective grantee or lessee (White Paper page 38);
- Renew leases with minimum conditions (White Paper page 38); and
- Improved data and mapping for tenure including surface and subsurface details.

This lack of action across issues of land tenure has impacted the achievement of the Two Year Outcomes relating to the Land section of the White Paper (see Chapter 4 below).

- 3.8 The Committee is delighted by progress on the commitments in the Water section of the White Paper. The bulk of these commitments involve in-depth evidence-based study into the current state of water assets, and the feasibility of proposals to augment existing water storages. These projects will drive economic and community development in Northern jurisdictions for decades. The Committee is confident that significant and important work is being done behind the scenes in order to inform Northern Australia's water policy and water management functions over the next 5, 10 and 20 years, and into the future.
- 3.9 The Committee notes that in the North the Commonwealth has no constitutional jurisdiction on rivers, streams and water management and has to rely on action by State and Territory governments. The Commonwealth Government can and does encouraged activity by funding feasibility studies and offering funding for construction (as in the case of the Rockwood Weir). The Committee strongly urges the Federal Government to continue and renew its efforts with State and Territory governments to advance into action any recommendations of these feasibility studies, and to pursue these matters through COAG and Northern Ministerial Forums.

- 3.10 The Committee applauds the outstanding progress made on the commitments in the Trade section of the White Paper. In August 2016 25.70 per cent of these commitments had been 'Completed'. One year later that figure has risen to 73.53 per cent. Almost all other measures detailed in the Trade stream of the White Paper are rated as 'In Progress'. The Committee is delighted by this achievement, especially as many of the Trade measures involve the regulatory and policy changes that are foundational to building a development- and investment-friendly environment in Northern Australia.
- 3.11 The Committee is pleased to note an increase in the 'Completed' measures in the Infrastructure stream over the past twelve months from 12.5 per cent to 31.25 per cent. The Committee is also very pleased to note that the number of 'In Progress' measures in this stream has increased dramatically from 37.5 per cent to 62.5 per cent. These 'In Progress' commitments include some of the most significant Commonwealth funding allocations made under the auspices of the White Paper. These include the 'Northern Australia Roads Program' (NARP) and the 'Beef Roads Program' which have already seen hundreds of millions of dollars allocated to specific road projects, many of which are currently under construction. The Committee looks forward to Northern Australia benefitting from the enhanced economic development that comes with better functioning supply chains, the improved amenity/access for residents and emergency services, from better tourism access, and from the improved agricultural outcomes that these major road infrastructure projects will deliver.
- The Committee is delighted to acknowledge excellent progress in the 3.12 Workforce area of the White Paper where the percentage of 'Completed' items has increased from 46.2 per cent to 61.55 per cent in twelve months. The percentage of measures rated 'In Progress' has also increased, from 23 per cent to 30.80 percent. This means the overall 'Actioned' figure has risen from 69.2 per cent to 92.35 per cent. This is an outstanding result. The Committee is not concerned by the few 'No Action' items that remain, which include Secondment of APS employees to the Northern territory to fast track implementation of the streamlined occupational licensing process, although the Committee notes the Deputy Prime Minister's mention of other APS positions in Darwin. Following high completion-rates in this portfolio stream thus far, the Committee is confident that the remaining measures will be actioned swiftly.
- The Committee is also pleased with the solid progress that has been made on measures in the Governance section of the White Paper. The 'Completed' percentage has risen from 18.2 per cent to 37.5 per cent, and the 'No Action'


percentage has almost halved from 45.4 per cent to 25 per cent. The Committee notes that it is the National Map Open Data Initiative - Northern Australia layer, and the update of Land surveys, area plans and zoning maps across a range of Indigenous communities in Queensland, Western Australia and the Northern Territory to support changes to land tenure that are more consistent with freehold title, that have so far received 'No Action'. As mentioned previously, successful actioning of such measures requires the commitment of State and Territory governments.

- 3.14 The Committee is generally encouraged by the pace of implementation across the second year of the White Paper's life. A combined 'Completed' and 'In Progress' figure of 87.25 per cent amply demonstrates that the momentum of the implementation of the measures in the White Paper has been steady and strong across the first two years of the White Paper's life. The Committee cautions, however, against allowing the evident tempo of work to foster any complacency in the on-going implementation of the White Paper, and in the further development of Northern Australia policy.
- 3.15 A detailed progress report on the implementation of the White Paper is at Appendix A.
- 3.16 The five-year, ten-year and twenty-year benchmark objectives of the White Paper are detailed at Appendix B.
- 3.17 The Two Year Outcome benchmarks detailed in the White Paper are discussed in the next chapter of this Report.

Two Year Outcomes

- 4.1 Pages 125 to 131 of the White Paper detail the impacts and outcomes on Northern Development intended to be achieved by the White Paper at two, five, ten and twenty year benchmarks from the release in June 2015.
- 4.2 The Committee is delighted to report that on the second anniversary of the release of the White Paper fifty-three (53) of the sixty-eight (68) outcomes proposed for the two-year benchmark, have been completed. Of the remaining fifteen (15) outcomes, five (5) are in progress, eight (8) remain idle and two have been discontinued. As such, the following 'Two Year Outcome' completion rates have been achieved:

- 77.95 per cent completed;
- 08.82 per cent in progress;
- 10.28 per cent no action; and,
- 02.95 per cent discontinued.



4.3 The status of each individual Two-Year Outcome is as follows. It should be noted that many of these outcomes are 'conceptual' in nature and refer to the state of play in the north as a result of the implementation of the measures in the White Paper. Only a limited number of specific measures from the White Paper are mentioned.

4.3 **Two Year Outcomes Completed:**

- Commence lower skilled worker pilot programme for workers from the Pacific Microstates.
- Broaden availability of Industry Skills Fund to support business in the North.
- Put in place Indigenous employment and supplier use targets for road projects.
- Review Working Holiday maker Visa to assess impact on the domestic labour market.
- Tourism industry to submit proposals to trial seasonal worker programme.
- Productivity Commission Inquiry report on Workplace Relations Framework released.
- Release Productivity Commission Inquiry report on Migrant intake into Australia.

Governance

- Continue Strategic Partnership between the Prime Minister and the Queensland, Northern Territory and Western Australian First Ministers.
- Seek support of the Parliament to establish the Joint Select Committee as a standing committee - The Joint Standing Committee on Northern Australia is appointed under a resolution of appointment which was passed by the House of Representatives on 1 September 2016 and the Senate on 12 September.
- Commence public sector secondment programme.
- Deputy Prime Minister's (Minister's) inaugural statement to Parliament on developing the North. Now Northern Australia Minister's report – delivered on Tuesday October 11, 2016.
- Release of the 2015 Defence White Paper
- Shift the Office of Northern Australia to the North.
- Establish a Single Point of Entry in Darwin.
- Joint select Committee's annual report to Parliament.
- Strengthen biosecurity functions in the North with more frontline officers.

4.4 Two Year Outcomes **In Progress**:

Water

- Complete Nullinga Dam and Ord Stage 3 feasibility assessments and progress projects based on results.
- Complete resource assessments in priority catchments Mitchell River, west Kimberley and Darwin.

Trade

- Release value proposition on investor-ready projects in the North.
- Consult with Indigenous Australians and business on accrediting jurisdictions' heritage protection regimes.
- Devolve aquaculture management in Commonwealth waters to the States and Territories.

Infrastructure

- Finalise plan for improving aviation connections to the North.
- Deregulate the current coastal shipping framework to ensure efficient and reliable coastal shipping services.

4.5 **Two Year Outcomes No Action:**

- Undertake cadastral surveys in targeted communities to support property rights.
- Consult on new models for managing native title funds for development.

Infrastructure

- Publish Northern Australia Infrastructure Pipeline (to be updated continually).

The Next Steps

- 5.1 The Committee notes the substantial progress achieved over the past 12 months indicates consistent momentum in the implementation of the measures in the White Paper.
- 5.2 It is crucial to the future prosperity of the North – and to ensuring the North's continued contribution to the prosperity of the nation – that this momentum continues.
- 5.3 The Committee notes, however, that full implementation of the White Paper is only the beginning of the development of Northern Australia. Alongside the implementation of the White Paper, the Government should be developing additional plans for the on-going development of the North in order to ensure that the pace and momentum of development continues, and that Northern Australia is able to capitalize on the foundations being laid by the implementation of the White Paper.




Sensitivities and Other Developments

6.1 The Committee notes a number of activities and plans for new developments, across Northern Australia that should be acknowledged when compiling strategies to complete the implementation of the White Paper, and progress Northern Australia's development beyond the scope contemplated by the White Paper. There are also a number of sensitivities. These include but are not limited to:

- \$2.25bn Australia Singapore Military Training Initiative which is a component of the Australia-Singapore Comprehensive Partnership (CSP);
- Adani's Carmichael Mine and Abbott Point developments;
- Coal mining across the Galilee Basin;
- Water Security across Northern Australia;
- Energy Security and Energy costs across Northern Australia;
- Major Projects such as Sea Dragon aquaculture development and Ord Stage 3;
- Infrastructure developments outside the scope of the White Paper (e.g., \$100m commitment to sealing entire Outback Way);
- Location of manufacturing and maintenance hubs for ADF upgrades e.g., Land 121 and Land 400
- Recovery across mining and resources sector;
- Unemployment in Northern Regional centres;
- Queensland Nickel insolvency;
- The fact that many of the commitments in the White Paper particularly those related to water, land tenure and pastoral leases – are within the jurisdictions of State or Territory Governments;
- The need to re-focus attention and engagement on Local Government Authorities across the North as the statutory bodies "at the coalface";
- On-going Local Government NDRRA funding and compensation issues;

- Reversal of the shrinkage of the Northern skills/knowledge base following skilled employees seeking opportunities elsewhere during the mining downturn;
- Continuing tension between Queensland, the Northern Territory and Western Australia due to the erroneous perception that it is a 'North Queensland White Paper' and that Queensland gets the bulk of the funding and attention; and
- Issues with construction activity funded by governments and the impact of the Commonwealth Procurement Rules on the ability of Northern businesses and work-forces to extract full benefit from the Federal Government's Northern initiatives.



Recommendations of the Northern Australia Oversight Committee

Recommendation 1

7.1 That the commonwealth renew its efforts in implementing the land tenure and pastoral lease commitments made in the White Paper (detailed at paragraph 3.6 of this Report) in order to foster certainty for holders of native title and for pastoralists, and to foster investor confidence.

Recommendation 5

7.5 That the relocation of Commonwealth public sector employees to the North be achieved at the earliest opportunity and be made a priority across the entire public service, noting that the Deputy Prime Minister has embarked upon such a program in other parts of Australia, including the proposed relocation of some functions of the Australian Animal Health Laboratory to Darwin.

Recommendation 6

7.6 That the newly-formed Ministry for Home Affairs have its training and logistical centers based in Northern Australia.

Recommendation 7

7.7 Acknowledging the benefit of input to policy from key stakeholders, that the Northern Australia Advisory Group, chaired originally by the Hon Shane Stone AC, be re-convened to make recommendations to Government on the next phases of Northern Australian development.

Recommendation 8

7.8 The Committee recognizes the importance of the coral reefs to the ecological biodiversity of Northern Australia (White Paper page 147) and the contribution such reefs make to the economy of North Eastern and North Western Australia through tourism (White Paper page 151) and therefore small business. The Committee recommends that the Government re-double its efforts to promote the Great Barrier Reef Marine Park, and marine parks generally, and is proactive in countering misleading reports of the health of the Great Barrier Reef Marine Park which have had a deleterious impact on tourism and small business in the North.

Recommendation 9

7.9 That the relevant Ministers be briefed on the White Paper's Five-Year Outcomes (White Paper pages 126-131) to ensure that planning can commence on achieving these benchmarks by Q3 2020.

Recommendation 10

7.10 That the Commonwealth Government give further consideration to proposals to develop pathways for immigration into regional and remote areas of the North to assist in stimulating population growth and skills diversity, as discussed on pages 111 to 114 of the White Paper.

Applications will be accepted from individual PBCs, groups of PBCs, or third parties authorised to administer funds on behalf of PBCs. Applicants must meet other eligibility criteria outlined in the IAS Grant Guidelines and undergo financial viability checks and a risk assessment.

There is no closing date for applications and the Department will consider applications throughout the year.

Applications for loans will be assessed against projects' cost effectiveness and financial viability. The loan recipient will make interest-only payments for up to the first five years of the loan term and will then have a further 10 years to repay the principal and any additional interest.

The six month restriction working with a single employer resets and applies again in the second year, although it is possible to return to the same employer from the previous year for another six months. In 2006 the option of a second visa became available to those working in any regional primary industry, such as mining. In February 2008 the option extended to people who had worked for three months in construction industries in regional areas.

On 8 February 2016, the Australian Government announced further expansion of the Seasonal Worker Programme, from primarily horticulture to the broader agricultural sector. Employers in a range of agriculture industries including cattle, sheep, grain and mixed enterprises will now be able to apply to be part of the Seasonal Worker Programme.

On 6 May 2016, the Australian Government announced the commencement of a tourism pilot under the Seasonal Worker Programme, specifically for Northern Australia. This pilot is one of the workforce measures announced as part of the White Paper on Developing Northern Australia.
