Fee & levies Schedule 2027 – Estimate only

The **Diocesan Tuition Fee** is set by the Catholic Diocese of Cairns. It is charged to assist with the costs of providing tuition by quality teachers. This amount is an estimate only at this stage and is published by the Catholic Diocese in November 2026 for the following year.

The **College Resource Levy** covers costs of items required by students to attend and participate in classes, and in student activities. This includes teaching and classroom resources, technology and library resources, camps, retreats, excursions, year level activities, photocopying costs, and other support and administration service costs.

The **Building Levy** funds the capital and maintenance costs of our buildings and facilities.

The **Laptop Hire Levy** will apply to our total cohort from 2027, which is in place for a period of three years. New devices are issued to each Year 7 and Year 10 Cohort each year.

The **P&F Levy** supports Family Connect initiatives and subsidises some College functions and activities. The amount is set by the Family Connect Committee.

The **Work Experience Levy** is charged to Year 10 students, being the charge incurred to engage the Work Experience Placement providers. This is a one-off annual charge applied in Term 1.

The **Work Placement Levy** is charged to Year FULL VET students in Year 11 only. This fee is for the cost of engaging a third-party provider to establish work placement whilst conducting the student's certificate work placement. This one-off fee charged is for the two years of the placement.

Other charges may also be billed, where applicable.

- The replacement cost of any College resource not returned after recovery processes have been exhausted, such as library books and textbooks.

- Replacement of ID Cards.

- Repairs or replacements under the Laptop Hire agreement.

My School Connect

Starting in 2026, all extracurricular charges are to be invoiced and paid via the My School Connect portal. Parents and carers will be required to setup an account and transact through this portal. This covers items such as tuckshop, uniforms, instrumental music lessons and sports trips.
