## YEAR 10 2024

### VOCATIONAL EDUCATION AND TRAINING (VET)

Vocational Education and Training (VET) is offered primarily to Yr 11 and 12 students at St Mary's Catholic College. However, if students are looking to get a head start in developing their vocational skills and knowledge, there are some options available to Yr 10 students.

Engineering studies and Furnishing studies are not VET certificates; rather they could be considered as 'Pre-VET'. They are intended to give students an introduction to the workshop environment, how to work safely in these environments and a chance to begin developing the skills and knowledge required in the certificates available the following year.

The Certificate I in Hospitality is the only certificate course available at St Mary's that Yr 10 students can enrol in. As it is a VET certificate, successful completion may see a student awarded up to 2 QCE points. This certificate gives students an introduction to the hospitality industry, how to work safely in these environments and a chance to begin developing the skills and knowledge that would assist in the Certificate II and III in Hospitality Qualifications available the following year.

**Please note:** these subjects are not prerequisites for VET offerings in Yr 11. Whilst it is strongly suggested you enrol in a relevant Yr 10 course/s if you are considering enrolling in a VET certificate in Yr 11, it is not compulsory.

## SIT10222 Certificate I in Hospitality

### Qualification description

This qualification reflects the role of individuals who participate in a range of routine and predictable hospitality work activities. They work under close supervision and are given clear directions to complete tasks.

This qualification provides a pathway to work in various hospitality settings, such as restaurants, hotels, motels, catering operations, clubs, pubs, cafes and coffee shops.

The skills in this qualification must be applied in accordance with Commonwealth and State/Territory legislation, Australian Standards and industry Codes of Practice.

No occupational licensing, certification or specific legislative requirements apply to this qualification at the time of publication. Refer to [training.gov.au](http://training.gov.au) for specific information about the qualification.

### Entry requirements

There are no entry requirements for this qualification. Students must create a USI number and provide to VED Administration.

### Duration and location

This is a one year course delivered in Year 10 on site at the Green Leaf Cafe, St Mary's Catholic College.

### Uniform

Closed in black leather shoes. Further PPE supplied (apron and cap/hair net). When working at functions, students are to wear black pants (not tights) and a black polo.

# YEAR 11 AND 12 2024

## VOCATIONAL EDUCATION AND TRAINING (VET)

Vocational Education and Training (VET) is offered to senior students in one of two ways at St Mary's Catholic College. Students may either elect to study a VET certificate on a subject line or as part of the full VET pathway.

### VET SUBJECT LINE PATHWAY

In 2024, the following qualifications may be offered to all Year 11 students on a subject line for student selection. Those indicated will be offered through Third Party Agreements. All course offerings are dependent on numbers of students and ability to access qualified trainers.

### FULL VET PATHWAY

Students attend college three days a week (Monday, Tuesday and Wednesday), train for one day (Thursday or Friday) and complete structured work placement one day a week (Thursday or Friday).

Three days attendance at school means that subject choice is limited to five subjects on certain lines. At the end of Year 12, students may receive a QCE and an ATAR if they meet the requirements.

*Subjects for 2024 are: (all subject information can be found on the College website).*

- *Essential English OR General English*
- *Essential Mathematics OR General Mathematics*
- *Religion and Ethics*
- **2 Electives<sup>^</sup>** – Student Choice (see below)

Please note: All electives are offered based on class numbers and qualified trainers. If a student wants to choose a **general** subject on the given line, this needs to be negotiated with the Careers Advisor.

### TRAINING

St Mary's Catholic College Trade Training Centre may offer the following Certificate courses for one day per week from 8.00am to 4.00pm. Thursday or Friday training days will be allocated at the beginning of 2024.

St Mary's Catholic College ensures students will be given reasonable opportunity to complete certificates in line with the certificate's packaging rules. Course offerings are dependent on numbers of students and qualified trainers' availability.

Alternatives to the above courses and training providers will be considered by the College on an interview basis and must be approved by the Trade Training Centre Director prior to enrolling.

### QLD CERTIFICATE OF EDUCATION

If a student meets all requirements of the QCE, he/she will be issued the Queensland Certificate of Education at the completion of Year 12.

With less time at school, considerable effort is given to including the students in as many activities as possible to enable them to feel part of the College. However, in some instances, this is not feasible and students may miss the occasional activity.

### STRUCTURED WORK PLACEMENT

Throughout the year, Full VET students must complete work placement each Thursday or Friday. **This is a requirement of enrolment in the VET pathway.** Structured work placement ideally relates to the Certificate course/s being studied.

Students who have obtained a school-based apprenticeship or traineeship (SAT) with an employer are paid for the time they work and have time taken off their apprenticeship.

Students are not able to complete Structured Work Placement with a business owned or managed by a direct relative.

Initially, in year 11, VPG may be contracted to organise Structured Work Placement for students for the first 12 months on behalf of St Mary's. If a placement is cancelled in year 11, depending on the circumstances, a new placement will be sourced by the student. **In year 12, students will be responsible for sourcing their own placement** as this assists the student in getting ready for the workforce. Students struggling to secure a work placement are to notify the Trade Training Centre Director promptly for assistance. Work Placement Agreements are current for a 12 month period. Placement is term time only.

## UNIFORM REQUIREMENTS AND EXPECTATIONS

Uniform requirements for all certificate courses at St Mary's in 2024:

**Automotive (full day)** – Students must always wear correct uniform including PPE on the full training day and Industry placement day. Uniform consists of steel capped boots, cotton drill pants (short or long) and cotton drill shirt. St Mary's will supply one shirt at the start of the VET year. Additional shirts will incur a cost.

**Construction (full day)** - Students must always wear correct uniform including PPE on the full training day and Industry placement day. Uniform consists of steel capped boots, construction work shorts, hi visibility work shirt – long sleeved preferred for sun protection. St Mary's will supply one shirt at the start of the VET year. Additional shirts will incur a cost.

**Engineering (full day)** – Students must wear correct uniform including PPE. Uniform consists of steel capped boots, cotton drill pants (short or long) and cotton drill shirt (short or long). St Mary's will supply one shirt at the start of the VET year. Additional shirts will incur a cost.

**Hospitality (full day)** – Students must wear correct uniform including PPE. Uniform consists of black pants (loose fitting black slacks, no tights) black, Green Leaf Café t-shirt and black leather closed in shoes. St Mary's will supply one shirt at the start of the VET year. Additional shirts will incur a cost.

**Furnishing (subject line only)** – Normal school uniform. Shoes must be enclosed leather uppers (no sports shoes). Apron provided. PPE provided.

**Electrotechnology (subject line only)** – Normal school uniform. Shoes must be enclosed leather uppers (no sports shoes). PPE provided.

**Engineering (subject line)** - Normal school uniform. Students are to bring a cotton work shirt to change into. Shoes must be enclosed leather uppers (no sports shoes). PPE provided.

**Hospitality (subject line)** – Normal school uniform. Shoes must be enclosed leather uppers (no sports shoes). PPE provided.

**Business (subject line only)** – There are no specialised uniform requirements for this certificate. Uniform is to be worn according to St Mary's uniform expectations.

**Fitness (subject line only)** – Students will be required to wear St Mary's sports uniform when practical tasks are to be completed.

ALL STUDENTS ARE RESPONSIBLE FOR REGULARLY WASHING THEIR UNIFORM.

Uniforms can be stored in students' lockers for safe keeping. There is a change room in the Trade Training Centre.

Note that if you do not bring the required uniform, you will not be able to complete practical activities and will be required to do theory (first incident). Repeat incidents will result in Student Support Office referrals and possible family meetings to review your position in the VET programme.

Students should purchase additional work wear for their work placement and should enquire with their host employer to confirm the requirements of the workplace.

## USI

A **USI (Unique Student Identifier)** must be obtained to be enrolled in any certificate course. If students do not hold a USI, they can obtain one by visiting <https://www.usi.gov.au>.

## ISSUES TO CONSIDER

Undertaking a VET certificate or embarking on the full VET pathway should be considered carefully. Students must think about the following questions if they wish to succeed in the St Mary's VET program.

- Am I prepared to work hard?
- Can I organise transport to and from training and work placement?
- Do I want to receive an ATAR?
- Am I committed to successfully combining work placement, training and school?
- Can I act responsibly in the workplace?
- Can I act responsibly in the Trade Training Centre and/or Green Leaf Café?
- Am I aware that the VET pathway does not guarantee employment?

## FEES

Students undertaking Vocational Education and Training Studies in Years 10, 11 & 12 will pay full school fees. Where the vocational studies subjects are conducted at St Mary's and a certificate is undertaken, additional levies may be applicable. Please refer to '[College Fees and Charges](#)' on the St Mary's Catholic College website for the most up to date fee structure.

## VETiS FUNDING

The Department of Employment, Small Business and Training (DESBT) provides funding for secondary school students to complete one (1) approved VETiS qualification while at school, referred to as 'employment stream' qualifications.

This means that if a student is eligible, the course is provided to them fee-free. To be eligible to enrol in a VETiS program, students must:

- be currently enrolled in secondary school
- permanently reside in Queensland
- be an Australian citizen, Australian permanent resident (includes humanitarian entrant), temporary resident with the necessary visa and work permits on the pathway to permanent residency, or a New Zealand citizen
- not already completing or have already completed a funded VETiS course with another registered training organisation.

In situations where a student is not eligible for VETiS funding, under the DESBT funding arrangements, fee for service arrangements is available for students. Please see the TTC Director for further information.

## FEES – EXTERNAL RTO’S

Where students undertake Vocational Studies courses at other Registered Training Organisations (eg TAFE), and VETiS (Vocational Education and Training in Schools) funding may not be an option, parents are responsible for the payment of fees directly to the RTO. The College will reimburse a portion of the tuition fees (not material costs) billed by that RTO. Proof of payment (receipt) is to be provided to the College for the rebate to be paid. Please refer to [‘College Fees and Charges’](#) on the St Mary’s Catholic College website for the most up to date reimbursement policy.

**Please note that Certificate courses with other RTOs can range between \$0 - \$20,000, depending on accessible government funding.** Please seek clarification/guidance with the Trade Training Centre Director or Coordinator before engaging an external RTO in a certificate course.

Should students sign up for a School-based Traineeship or Apprenticeship, the government department, DESBT, may pay the full tuition fees directly to the Registered Training Organisation if funded under User Choice. In these cases, there is no parent payment of tuition fees, nor any refund from the college.

## FULL VET PATHWAY SELECTION

**To be considered for the full VET pathway, students must complete the EXPRESSION OF INTEREST form. These will be distributed after all students complete the SETPlan interview. This will need to be completed by the date indicated and submitted in person to Trade Training Centre reception.**

**This is not a subject selection form. An interview with the Trade Training Centre Director will be organised with Parents/Guardians along with the student. A certificate course for the full day of training (Thursday or Friday) will be selected at this interview.**

**Students who do not meet all requirements at any stage throughout the course will be interviewed by the Principal and the Trade Training Centre Director and may find their enrolment in the VET program terminated.**

## AUR20720 Certificate II in Automotive Vocational Preparation

### Qualification description

This qualification reflects the role of individuals who perform a limited range of tasks relating to identifying and inspecting mechanical and electrical components and systems of light vehicles, heavy vehicles, outdoor power equipment, bicycles, marine craft and motorcycles. This qualification also covers the skills and knowledge required to perform minor maintenance and repair of an automotive vehicle body. The range of technical skills and knowledge is limited.

### Entry requirements

There are no entry requirements for this qualification. Students must create a USI number and provide to VED Administration.

### Duration and location

This is a two-year course delivered in Years 11 and 12 (covering 7 projects) on site at the Trade Training Centre, St Mary's Catholic College.

### Uniform

Students must always wear correct uniform including PPE on the full training day and Industry work placement day. Uniform consists of steel capped boots, cotton drill pants (short or long). One shirt is provided – students may need to purchase an additional shirt.

It delivers broad skills and knowledge in furniture making tasks which will enhance the graduates' entry-level employment prospects for apprenticeships, traineeships or general employment in a furniture manufacturing environment or related workplace.

No licencing, legislative, regulatory or certificate requirements apply to this qualification at the time of publication.

There are no entry requirements for this qualification. Students must create a USI number and provide to VED Administration.

Normal school uniform. Shoes must be enclosed leather uppers (no sports shoes). Aprons provided. PPE provided.

## CHC30221 Certificate III in School Based Education Support

Your son/daughter has expressed interest in undertaking the Certificate IV in Justice Studies (10971NAT) course. This qualification is a nationally recognised qualification and the course is externally assessed and run by Unity College.

This qualification is an excellent opportunity for High School students to take the first step towards a successful career in the justice industry. They will obtain a head start in the local job market and can use the qualification as a step towards further education. This course can help prepare students for the Bachelor of Criminology and Justice at the University of the Sunshine Coast or a Bachelor of Justice at other universities. The course also has close links with the Diploma of Crime and Justice at TAFE QLD, with Queensland Courts and with the Queensland Police. The course is developed alongside industry personnel.

#### Calculating ATARs

If a student is eligible for an ATAR in both categories, QTAC will use their highest ATAR.
